2026 FIRE DEPARTMENT TRAINING NEEDS

WHEREAS the By-law respecting the conditions to practice within a municipal fire safety service provides for the training requirements for firefighters of fire safety services in order to ensure a minimum professional qualification;

WHEREAS this by-law is part of a desire to guarantee municipalities the training of firefighting teams with the necessary skills and abilities to respond effectively in emergency situations;

WHEREAS in December 2014, the Government of Quebec established the Financial Assistance Program for the training of volunteer or part-time firefighters and that it has been renewed in 2019;

WHEREAS the main objective of this Program is to provide municipal organizations with financial assistance to enable them to have a sufficient number of qualified firefighters to act effectively and safely in emergency situations;

WHEREAS this program is also intended to promote the acquisition of the skills and abilities required by volunteer or part-time firefighters who work in municipal fire safety services;

WHEREAS the Municipality of Bristol wishes to benefit from the financial assistance offered by this program;

WHEREAS the municipality of Bristol plans to train 9 firefighters for the Firefighter I program during the next year in order to respond efficiently and safely to emergency situations on its territory;

WHEREAS the municipality must transmit its request to the Ministère de la Sécurité Publique through the MRC Pontiac in accordance with article 6 of the Program.

IT IS PROPOSED by Meaghan McConnell and **SECONDED** by Steve Gray and resolved to present a request for financial assistance for the training of these firefighters within the framework of the Financial Assistance Program for the training of volunteer or part-time firefighters to the Ministry of Public Security and to transmit this request to the MRC of Pontiac.

OPPOSING BILL 106 (Loi 2)

WHEREAS negotiations between the Government of Québec and the physicians’ federations have failed regarding Bill No. 106;

WHEREAS the minister of Health refused to use an independent arbitrator, as requested by the FMSQ and the FMOQ, during negotiations concerning Bill No. 106;

WHEREAS on October 25, 2025, Bill No. 2, entitles “An Act mainly to establish responsibility for improving access to medical services and to continuity of these services”, was adopted;

WHEREAS the special legislation was adopted under closure, without any consultation process with the parties concerned;

WHEREAS Bill No. 2 suspends the renewal of the physicians’ framework agreement and the overall physicians’ remuneration envelope until 2028;

WHEREAS Bill No. 2 provides for fines and sanctions against physicians, representative physician groups, their directors, employees or representatives, universities with a faculty of medicine, as well as university directors and representatives involved in collective actions;

WHEREAS Bill No. 2 imposes unrealistic performance targets the jeopardize the quality of care;

IT IS PROPOSED Meaghan McConnell and **SECONDED** by Greg Graham and resolved to present opposition by the Municipality of Bristol against to bill 106 (Loi 2).
