

The regular meeting of the Bristol Council was held on October 1<sup>st</sup>, 2025 at 8:00 p.m. with Mayor Brent Orr, and Crs. Valerie Twolan-Graham, Archie Greer, Meaghan McConnell, Greg Graham, Kim Crawford and Debbie Kilgour.

**(25-10-130)** Motion Cr. Greer that the minutes from the September 2<sup>nd</sup> meeting be adopted as presented. Crd. The Mayor abstains from voting.

**(25-10-131)** Motion Cr. McConnell to adopt the agenda with the additions. Crd. The Mayor abstains from voting.

**(25-10-132)** **Minor Variance**

**WHEREAS** the Ministry of Quebec stipulates a 10 m protection strip along the river which is less severe than Zoning By-Law 312A.1, Article 4.12.6, which indicates a 15 m protection strip allowing the municipality to grant a 12 m protection strip, and still respect the ministry's regulations;

**WHEREAS** the building addition has no negative impact on neighbouring properties;

**WHEREAS** the improvements to the cottage will enhance the aesthetics of the area;
