



## **PUBLIC NOTICE OF THE REVISION OF THE LIST OF ELECTORS FOR VOTING DAY: NOVEMBER 2, 2025**

**By Public Notice**, Christina Peck, Returning Officer for the Municipality of Bristol, announces the following to the electors of the municipality:

Due to the ongoing **postal strike**, the Municipality of Bristol is currently **unable to send out the information cards confirming those registered on the voters list** for the Bristol Election and the MRC Pontiac Warden Election.

1. The list of electors was filed with the office of the municipality on October 3rd, 2025.  
It is currently under review.
2. To vote, you must be entered on the list of electors.
3. You have the right to be entered on the list of electors if, on voting day:  
You are 18 years of age or older;  
You are a Canadian citizen;  
You have not lost the right to vote due to a tutorship;  
You have not been convicted of a corrupt electoral practice in the previous five years.

**IN ADDITION, you must meet one of the following two conditions on November 2nd, 2025:**

1. Be domiciled on the territory of the Municipality of Bristol and for at least six months in Québec.
2. For at least 45 days, own an immovable or occupy a business establishment located on the territory of the Municipality of Bristol.
3. If you are an elector domiciled in the Municipality of Bristol, you will be able to consult the list of electors and submit an application for entry, striking or correction before the board of revisers at the following address during the dates and times listed.

**Location:** 32 Aylmer Road

**Dates & Times:** October 14, 2025 10:00 a.m. to 5:30 p.m.

October 15, 2025 5:00 p.m. to 8:00 p.m.

### **Required documents:**

To apply for entry on the voters list, you must provide one or two supporting documents which, together, show your name, date of birth and address. If you are applying to register **another person**, you must also provide their **previous domicile address** and the same two types of documents as indicated above.

If your **residence is located outside the municipality**, but you **own property** or **operate a business establishment** in Bristol, you must now present yourself at the Revision on the dates and times listed above, since the deadline of September 28<sup>th</sup> for sending the forms SMR-9.1 and SMR-9.2 directly to the office has passed. If you are a **co-owner** or **co-occupant**, you must bring a completed **power of attorney (SMR-9.1)** to the Revision, however only the person registering to vote needs to be present at the Revision.
